

The Udall City Council met for the City Council Meeting on Wednesday September 13th, 2023, at 6:30pm at the Udall City Building Council Room. Matt McAllister, Mayor, called the meeting to order. Council members present were Randy Hoffman, Damon Wilson, Dan Rutschman and Jim Caywood.

Quorum established. Also present were Jennifer Mays, Erik King, Eric Allen, Jason Goza, Tyler Goza, Darren Booth, Marilyn Pellegrini, Gina Hoffman.

Modification to Agenda – Add Darren Booth from FCMI as the 2nd line item under new business. MOTION by Wilson to approve the modified consent agenda. SECONDED by Hoffman. McAllister called for a vote. All Ayes. MOTION carried.

<u>Business from the floor</u> – Marilyn Pellegrini – Fall Festival. Requesting use of the city park and Police and Maintenance presence. MOTION by Wilson to approve the park and wages for all work needed for the Fall Festival. SECONDED by Hoffman. McAllister called for a vote. All Ayes. MOTION Carried. CMB Renewal – MOTION by Wilson to approve CMD license renewal for the Fall Festival. SECONDED by Rutschman. McAllister called for a vote. All Ayes. MOTION carried.

Ordinance 691 – Corrected Ordinance 592 which had an incorrect number to 691. MOTION by Wilson to approve correction to Ordinance 592 to the correct number 691. SECONDED by Caywood. McAllister called for a vote. All Ayes. MOTION Carried. WIFI – Discussion – no binding action taken.

<u>Lumber yard</u> – since there was a miscommunication between the city and D&T's Hauling and Excavation regarding the removal of all concrete, vote on waiving any late charges incurred through completion of removal of concrete. MOTION by Caywood to approve waiving the late fees. SECONDED by Rutschman. McAllister called for a vote. All Ayes. MOTION Carried.






