**RESOLUTION NO. 351**

A RESOLUTION CALLING FOR AN ELECTION TO BE HELD ON WHETHER A GENERAL SALES TAX OF ONE PERCENT (1%) ON ALL RETAIL SALES WITHIN THE CITY LIMITS OF THE CITY OF UDALL, KANSAS SHOULD BE CONTINUED FOR AN ADDITIONAL 10 YEARS FOR THE PURPOSE OF DEFRAYING THE COSTS OF PHASE II AND PHASE III WATER PROJECTS AND OTHER INFRASTRUCTURE IMPROVEMENTS FOR THE CITY OF UDALL, KANSAS

WHEREAS during a general election held April 7, 2015, the voters of Udall, Kansas, passed a question allowing the governing body of the City to impose a one percent (1%) sales tax starting October 1, 2015 and extending to September 30, 2025 for the purpose of defraying the costs of Phase I and Phase II Water Projects and other infrastructure improvements for the City of Udall, Kansas;

WHEREAS as a result of the April 7, 2015 general election vote, there was imposed on all retail sales within the city limits of the City of Udall, Kansas, a one percent (1%) sales tax be used for the purpose of defraying the costs of Phase I and Phase II Water Projects and other infrastructure improvements for the City of Udall, Kansas;

WHEREAS the sales tax is set to expire on September 30, 2025 when it shall end, unless extended, by vote at general or special election;

WHEREAS the City of Udall, Kansas deems it advisable put the question to the voters of Udall, Kansas for the general election held on November 5, 2024 to extend the one percent (1%) sales tax be used for the purpose of defraying the costs of Phase II and Phase III Water Projects and other infrastructure improvements for the City of Udall, Kansas.

**BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF UDALL, KANSAS, AS FOLLOWS:**

**Section 1.** The above recitals are incorporated herein as if fully set forth.

**Section 2.** The City of Udall, Kansas Clerk shall send a copy of this resolution to the Cowley County Clerk asking that the following question be put to the voters of Udall, Kansas during the general election held on November 5, 2024:

Shall the City of Udall, Kansas, pursuant to the provisions of K.S.A. 12-187, be authorized to renew the levy of a one percent (1%) general purpose citywide retailers' sales tax within the City of Udall, Kansas; such tax, if approved by a majority of the electors voting thereon, to take effect on October 1, 2025, or as soon thereafter as permitted by law, and to end ten years after its commencement on September 30, 2035; the revenue from the renewed tax shall be used for the purposes of defraying the costs of Phase II and Phase III Water Projects for the City of Udall, Kansas; if approved, such tax shall continue the City's current one

percent (1%) citywide retailers' sales tax levied within the City?

To vote in favor of any question submitted on this ballot, vote "Yes." To vote against it, vote "No."

**Section 3.** The sales tax requested be imposed herein shall be used for the purpose of defraying the costs of Phase II and Phase III Water Projects and other infrastructure improvements for the City of Udall, Kansas.

**Section 4.** The sales tax requested be imposed herein shall be effective starting October 1, 2035 and extending to September 30, 2035 when it shall end, unless extended, at that time by vote at general or special election.

**Section 5.** Revenue from the requested imposed sales tax shall be deposited in the appropriate City account until approval for its disbursement is made by the City Commission.

**Section 6.** Notice of the election shall be published in Winfield Daily Courier once each week for two consecutive weeks. The first publication shall be not less than 21 days prior to the election. Notice of the election shall also be published on the website of the Cowley County election office. Such notice shall be published not less than 21 days prior to the election and shall remain on the website until the day after the election. The notice shall set forth the time and place of holding the election and the purpose for which the tax is to be imposed and shall be signed by the Cowley County election officer.

**Section 7.** This resolution shall be in full force and effect immediately. PASSED AND APPROVED BY THE GOVERNING BODY OF THE CITY OF UDALL, KANSAS THIS 14th DAY OF AUGUST, 2024.
